Women, Infants, and Children (WIC) Nutritionist II **Davie County Consolidated Health & Human Services Agency**

Description of work: The Nutritionist II is responsible for ensuring program quality and participating in the work of Health Department nutrition programs; the Special Supplemental Nutrition Program for Women, Infants, and Children (WIC), Diabetes Self-Management Program, and medical nutrition therapy services. The WIC Nutritionist III complies with and executes all policies and procedures of the WIC Program, working with people internal and external to the agency and unit with courtesy, tact, and sensitivity; responsible for managing the local WIC Program and providing clinical nutrition services. Regular, predictable, full attendance is an essential function of the job.

Education and Experience: Registered Dietitian with the Commission on Dietetics Registration; or Master's degree in Dietetics, Public Health Nutrition, or Nutrition; or graduation from a Commission on Accreditation for Dietetics Education- approved Didactic Program in Dietetics and two years nutrition experience; or Dietetic Technician, Registered with the Commission on Dietetics Registration with a Bachelor's degree in any subject area from an accredited four-year college or university and two years nutrition experience; or a Bachelor's of Science degree in Dietetics, Public Health Nutrition or Community Nutrition from an accredited four year college or university and two years nutrition experience. Candidates should provide documentation of registration status from the Commission on Dietetic Registration, and provide university or college transcripts or ACEND verification statement. Or, candidates can qualify as a Competent Professional Authority which includes: Is a physician or nutritionist (Master's or Bachelor's degree in Nutritional Sciences, Community Nutrition, Clinical Nutrition, Dietetics, Public Health Nutrition or Home Economics with emphasis in Nutrition), dietitian, registered nurse, physician's assistant certified by the National Committee on Certification of Physician's Assistants or certified by the State medical certifying authority, or a State or local medically trained health official. Has successfully completed a competency-based training program on performing the duties of a CPA. Have literacy and language skills appropriate to address the needs of diverse participants.
