Dear Secretary Cohen:

I send this letter as a follow-up to my letters dated June 3, 2021 and June 30, 2021. The enclosed resolution and Disengagement Plan were approved unanimously by the Davie County Board of Commissioners on August 2, 2021. With this action, the Davie County Board of Commissioners affirmed its commitment to disengage from Cardinal Innovations Healthcare and realign with Partners Health Management, consistent with the applicable statutes and regulations (NCGS § 122C-115(a3); 10A NCAC 26C.0701 - 10A NCAC 26C.0703).

Davie County, by this or other correspondence, provides notice to each of the counties served by Cardinal and Partners and the providers impacted by this disengagement.

Davie County will also solicit comments from consumers, advocates, self-advocates, and State and Local Consumer and Family Advisor Committees (CFACs) using locally established communication methods such as mailings, stakeholder meetings, press releases and social media messaging. Public comment is welcome and encouraged through an online submittal form and/or by mail addressed to:


