 - Davie County Recreation and Parks has adopted a Volunteer Criminal Background Screening Policy utilized to screen all volunteer positions that have direct contact with youth and/or any vulnerable adults whereby the individual volunteer may not be supervised by a county employee. Said policy is also utilized as a tool to determine if the individual offering to volunteer their time and efforts is the appropriate individual to work with our youth and other citizens in this capacity.

- My child does not have any criminal misdemeanor or felony adjudications, which may or may not appear on a criminal background check, that would disqualify my child from employment, internship, or volunteering with the County of Davie, Recreation and Parks Department.

7. WARNING OF PENALTY

I understand that if it is found that the information contained in this affidavit is false, the County of Davie, Recreation and Parks department may remove the applicant from his or her employment, or assigned internship, or assigned volunteer program activity, unless the applicant is otherwise eligible under other laws. I understand that if the applicant is removed from employment, assigned internship, or assigned volunteer program activity, the County of Davie, Recreation and Parks department shall provide an opportunity to appeal the removal in accordance with Davie County Recreation and Parks Code of Ordinances and shall notify me of this opportunity. I understand that if it is found that I willfully and knowingly provided false information in this affidavit, I may be found guilty of a class I misdemeanor and may be subject to citation, and penalty.
